Get in the Know: Fueling your safety culture

Peter Burgess of Perennia will be discussing the risks associated with pesticide use, focusing on exposure and toxicity and covering some basic measures required to keep yourself safe. **1 pesticide recertification point.**


Noon: Lunch will be provided

Training not only ensures the safety of your employees, it also promotes efficient and productive workplaces.



What training do we need on our farm?

As an employer you are responsible for providing your employees with the training they need to perform their duties. A question that is often asked and one that doesn't always have a straight forward answer, "What training do we need on our farm?". The fact is that the training required differs with every farm and you need to do a review of your operation to determine what training your employees need.

One of the best ways to determine what training you require is to do a task review. In terms of identifying training requirements, you would identify the tasks performed on your farm and then identify the training required for each task. While this may seem like a daunting task, you are already likely doing some of the training and you may have multiple tasks that require the same training.

For example, you may hire someone to do field work for you. This could include a variety of tasks (e.g. mowing, harrowing, baling) but the training required is very similar for each task. Yes, training for each particular implement may require some fine tuning, but the basic training required for these tasks is the same. The employee must be trained in safe tractor operation and how to hook-up and operate implements.

After identifying the training your employees need, you then need to decide where they will get that training. Some training may be delivered in-house and other by a third-party. The key is that whoever is providing the training must be competent. In the world of health and safety, competent means that you have an understanding of the task and an understanding of the applicable regulations. While there are certain trainings, such as first aid, that must be delivered by a certified body, much of the necessary training can be done in-house if you have a competent trainer in-house. If there is not someone in-house with an understanding of the task and applicable

regulations then you will have to have a third-party provide the training.

Recognizing that the training needed will depend on your farm, there are a number of training requirements identified in the regulations. While you will have to consult the regulations to determine your farm's requirements, here is a list of a few of the regulated training topics commonly required on farms:

- First aid
- WHMIS
- Forklift
- Confined space
- Fall protection

The most important thing to remember is that your employees must be trained to perform their jobs safely. This includes training for tasks such as tractor operation that are not necessarily specified in the regulations. Providing your employees with training is essentially providing your employees with the knowledge they need to perform their tasks. This not only ensures the safety of your employees, it also promotes efficient and productive workplaces. Make sure you keep a record of all the training you provide for your employees and have your employees sign those records. If it's not documented, it didn't happen. 🌱
